Federated Home and School Association Meeting Minutes November 12, 2020

Welcome: November Meeting

October minutes approved.

Board of Education Update:

Dr. Dan Fishbein, Superintendent

- > Thanked everyone for the tree gifted to him from the Federated Board on his retirement
- ➤ COVID-19 case reports
 - None have been linked to the schools ie not transmitted through school and therefore have not had to close school
 - Fortunate to have own health department in Ridgewood
 - Separate distinct cases in last letter (not linked)---may be due to Halloween, teacher convention week
 - For kids who come home from college, they should not test for 5 days; should quarantine from people at home
 - Rumors about closing after Thanksgiving and going virtual are false: some districts have not opened yet and may decide to do this
 - For districts that are open already, cannot close based on assumption that something will happen; must follow state guidelines
 - If governor closes all schools, then district must close
 - Spoke with state education dept yesterday, and no truth to rumor that schools will close after Thanksgiving
 - Ashley M: Requested that Dr. Fishbein address phase 2; Dr. Fishbein regrets giving a date for phase 2 but eventually phase 2 will be full day

- Dr. Fishbein showed numbers of cases lately----over 3000 positive cases yesterday; numbers increasing dramatically
- Mary M: Learned that school nurses are trained in contact tracing; Dr.
 Fishbein offered to help Valley Hospital in the spring with contact tracing by offering services of school nurses; helpful now in schools

Guest speakers: Christine Amundsen (RPS energy specialist) has been working in district for 6 years---reporting on Sustainable Jersey for Schools grants, etc.

- ➤ Monitor energy consumption by Synergistic
- ➤ Dr. Fishbein: have light sensors and other tools to monitor system to save energy and money
- ➤ Village at Silver level; program opened up to schools about 6 years ago
- 91 different actions that can be taken by schools toward Sustainable Jersey project
 - Once a certain level is reached, school can be certified
 - District cannot be certified; only individual schools can be certified but district can do certain actions that can be credited to all schools
 - o Schools only need to have a Green team
 - o Somerville received a grant
 - o Hawes received a grant a few years ago
 - o Additional grants are in the works
- ➤ **Joanna Hanrahan** is coordinator of Green team at Somerville and working with BF and other schools on implementing programs
 - o Encouraged all schools to form Green team
 - Encouraged all HSAs to promote program either Green Club or Sustainable Jersey for clubs
 - Encouraged each HSA to pursue program at their school and apply for grant---easy to do
 - Working on RPS district-wide grant w Federated (KB)

Mike Lembo, BOE

- ➤ COVID-19: Reiterated that Ridgewood is fortunate to have own health dept
- ➤ A tweet stating that Governor Murphy announced shutdown was fake news and debunked quickly by Dr. Fishbein
- Resolution to pass at next BOE meeting to make it official that Dr. Tom Gorman will be acting superintendent
- > Dr. Gorman will still be principal of RHS---will return to job when permanent superintendent is found
- Special session yesterday to review firms to consider new Board attorneys; potential firms were asked how they would transition current open cases to new attorneys without added costs and seamlessly
- Special session today to interview Architect of record; along with 6 other firms
- ➤ REA negotiations started last night: Ms. Kwak and Ms. Brogan will handle negotiations with REA (Mr. Lembo recused due to personal conflict)

- Scott Bisig (new RPS Business Administrator) to start officially on Jan 1, 2021; assistant BA to take on duties in meantime
- ➤ Attended RHS HSA meeting via Zoom last night---good turnout, and hopefully will more parents will continue to attend
- Search firm R-PAT Solutions hired to conduct new superintendent process; based locally and founded/run by a former superintendent and assistant superintendent
 - Survey to be sent to parents, community members invited to provide feedback and help determine RPS district's needs
 - o Application deadline is Dec 7, 2020 to narrow down choices
 - Web services now available to make it easier to obtain info

President's Update:

Kelly Buchsbaum, President

- ➤ Email on building use: no events on school grounds until after January
- ➤ Jennie Smith Wilson started scholarship in honor of Dr. Fishbein. The Daniel A. Fishbein Scholarship Fund will grant \$1,000 per year for 17+ years to an RHS senior
 - Federated HSA will be lending nonprofit status
 - Currently at \$17,450
 - New account will be opened for scholarship fund; Federated HSA Treasurer will be signer
 - Federated President will serve on scholarship selection committee with RHS administrators

Vice President's Report:

Amy Gill, 2nd Vice President

- Officially canceled Wizards game for January since school facilities cannot be used
- ➤ Still have April dates scheduled (4/27, 4/28)
- ➤ Todd R: Has a virtual event been considered if April Wizards game cannot be done? Example: Trivia night with schools vs each other or online Family Feud
- ➤ Wizards offering a virtual option----Wizards FitKids; will be a fundraiser
 - Todd R: Reluctant to do a virtual Wizards event; much effort for little reward; may not get a lot of participation; may not be as good as live option since they don't specialize in it
 - Consider sharing demo at Dec meeting if worthy of considering
- ➤ Possible enrichment alliance request: Grant request for \$1,500 for speaker to address vaping speaking to both GW and BF communities
 - Marijuana use---another possible program to educate now that marijuana will be legalized
- > Meeting with secondary school presidents scheduled after this meeting
- ➤ Amy: Had meeting yesterday with elementary school presidents; exchange of many creative ideas

Treasurer's Report:

Valerie Auyeung, Secretary/Treasurer

- Opened nonprofit Columbia Cares bank account for the Dr. Daniel A. Fishbein Scholarship Fund under Federated's 501c(3) number
 - Received many donations already and will far exceed the original goal of \$12,000

Member-at-Large Report:

Kathy Marshall, Member-at-Large

- ➤ Directory update: Requesting schools to send update on dues to compare from last year
 - All directories have launched
 - Continue to encourage everyone to sign up for GroupSpot
 - Can update partner posts and pin to top of feed
 - Since it is an HSA product, only communications that abide by district enews policy should be posted (eg should not post parent socials involving alcohol)
 - Mary: RHS executive board made decision---if cannot go in enews, cannot go in GroupSpot; has a dedicated GroupSpot person to handle the app; has been easy to make changes to directory
 - At first overwhelming to approve people who paid and grant them access when there are many who purchase all at once
 - Todd: Difficult to find directory on app; should be a featured option at the bottom
 - Kathy advised directory chairs to include directions on how to access directory when families pay their dues

Paul McCarthy (REF)

- ➤ Continuing close discussions with key district personnel to consider and identify educational initiatives where REF support would be beneficial
- ➤ Will reach out to each HSA president to request to attend HSA meetings in Dec or Jan to introduce REF members and provide updates
- ➤ NJ Governor formally signed legislation to ban plastic and paper bags---REF selling reusable bags; will be sold by Midland Park Acme (Acme will donate \$1 to REF for every \$3 bag sold)
- ➤ As President of Friends of Ridgewood Public Library as well requesting all to donate to current fundraising campaign RPL
 - Kelly B expressed appreciation for the services provided by the library during the pandemic

Elena Croy: RED HSA

- ➤ Karen Price is retiring from Glen School
- > Would like to create a video from current and former students and families to wish her farewell
- ➤ Will also collect for a gift; checks to RED HSA

- ➤ Will ask Jamie to reach out to LSHSA
- ➤ Will possibly organize a drive-by car parade

<u>Iamie England: LSHSA</u>

- ➤ Fundraiser at Chipotle this week
- ➤ Thanked everyone for supporting last fundraiser
- Survey sent out to parents regarding Special Programs
- Virtual socials will start tonight preK/elementary
 - Next week for middle and high schools

Special Guest: Mark Kossick (GroupSpot)

- Federated HSA leaderboard, total 2,180 as of 11/12/2020
- Added event reminders to app so notifications can be sent; can send push notifications as well that can be customized when it is sent before the event
 - Kelly A: Can reminders be used for subgroups? Mark: Has not been formatted yet for automated message but can do now manually using the app if subgroups are already formed in the app
- ➤ Web platform being requested---may be available in 2021
- Upgrading calendars on app; also photos on app
- Security: 2 factor authentications of signup of new member---can be turned on as an optional feature
- ➤ Can email class/grade---will be implemented
- Exchange search capabilities across directory
- ➤ Adding views capability for ads
- ➤ Kathy M: Overall debrief Zoom in January requested
 - Some parents have old platforms on phones and cannot use apps---is there a workaround? Mark will work on a solution.

Open Discussion:

- ➤ Christine M (Travell): DEI committee at school requesting own FB/Twitter account
 - o Kelly B: No guidance currently regarding social media separate accounts
 - DEI will be under guidance of Dr. Fishbein, Stacie Polestra, and principals; ensure direction and communication all come from principals
 - At this time, respectfully discouraging DEI to have own FB/Twitter account
 - Mary: At RHS, every class has own FB page but do not want to put volunteers in position to monitor FB page
