<u>Superintendent's Update:</u> Dr. Tom Gorman, Superintendent

PHS women's sports are dom

- RHS women's sports are dominating
- 1st Quarter ended last week
- Senior slide show pasta party occurred this week
- Successful vaccine clinic with 160+ students vaccinated at Village Hall yesterday; another clinic scheduled for Nov 18th
- Postcard will be sent out to inform about Alternative School Day
 - Presentation on Dec 1st at BF to discuss general info regarding Alternative schedule, and survey will be sent out after meeting
 - May have another meeting later, possibly Feb
- Continuing to recruit aides and substitutes; have many on list but often decline

• Teacher grant applications being accepted by REF; still giving money to large projects

• ESSER3 being used for HEPA filters; there are still funds remaining; asking community for input this week on how funds should be used

• Amy B: When will details be announced about Dec 1st meeting? Dr. Gorman: Postcard will be sent out and will also be posted in social media, emails, etc

• Jean: Where are the jobs being posted? Is there a shortage of special needs aides? Dr. Gorman: Jobs are being posted everywhere. Special needs aides

based on number of students with IEPs—-not due to budgeting issues. There is no shortage of aides for special needs students. There are no general ed aides; only lunch aides. ESSER3 funds cannot be used for general ed aides since it would not be sustainable after funds run out. Mary: LSHSA can be a good resource for special needs families who need support.

- Gorman: Want to keep students in district; least restrictive and keeping with friends; also less costly
- Kelly: Do applicants need formal background check and teaching certificate for substitutes? Gorman: Only need 60 credits and background check.
- Mike: There is a long list of substitutes who can be called but not everyone wants to work on a day they are requested.
- Gorman: Aides are only used at elementary schools for lunch—-fully staffed. However, special ed aides are transitory—-need full time aides.
- Mike: Encourage all parents to apply even if they can only work a few days a month

• Nancy: What is the official name of the Ridgewood Foundation? Mary: Will clarify with Paul McCarthy and ask him to give a short description of what REF does.

• Todd: Thoughts on info on vaccination rates survey and how it will be used. Gorman: Unsure if data can be used based on level of rates; mask mandate expires in January but unsure if it will be renewed

- "Test to stay" policy being discussed: if student exposed, a close contact would test daily to stay in school
- Vaccination rates based on voluntary survey responders: RHS 98%; MS 70%; entire staff 98%

Board of Education Update:

- ESSER3 funds: deadline on 11/24 to submit for approval; funds are earmarked for specific purposes ex mental health, teacher dev, health and safety; need to follow guidelines
 - Updated presentation on Mon's meeting
- COVID testing offered at BF every Wed from 3-6pm
- Vaccination clinic successful yesterday
- Alternative schedule: page on district site with info on alternative schedule
- Election occurred last week: unofficial results announced
- 3 Meetings remaining of the year; reorg meeting in Jan with new BOE members
- Nancy: What are you asking of the community for ESSER funds if a specified amount already earmarked for filters in schools? Gorman: Google form sent out last week. Mike: Breakdown is on district website.

- Wizards game 2022 updates: moving forward with dates, January 27 and 28
 - No concessions will be sold at the game; pizza restaurants will be used for no cook night for those 2 nights; send preferences for pizza restaurants
 - 100% masked during games
 - Wizards players are fully vaccinated; optional mask for players
 - Ridgewood's Got Talent competition for National anthem performer selection
 - Need help from HSAs to recruit players esp. for 2 nights (2 teachers per school per game)—-discuss with principals; need board members to help working during the game and publicizing to schools
 - 600 Tickets per game
 - Goodie bags a possibility
 - Also need sponsors
 - Nancy: What are the needs now? Amy: Name of preferred pizzeria
 - Mary: No cook nights spreadsheet will be created; will publish and send out in email
 - Amy: Suggest also coordinating list of scheduled holiday fairs and boutiques at the schools

- Insurance riders: can consolidate in terms of outside vendors and coverage of BOE

- Mary will compile list of vendors commonly used for events to see if more cost-effective way to have insurance coverage for vendors
- Amy B. will reach out to insurance company to see if a more costeffective way is available to obtain riders and COI

• Tasneem: Do fliers need approval from Superintendent's office to be distributed to other schools? Kelly: Need approval from Lucy Papamichael for schools' enews but not for GroupSpot. Mary: outside vendors need approval from Lucy Papamichael

• Tasneem: Can students' pics be used in social media posts? Mary: Must have permission from families in Skyward.

• Nancy: Can a DEI video of kids be posted in social media if parents give permission? Mary: Must be consistent with what parents signed off on in Skyward. May be more complicated and set a precedent for future situations.

Paul McCarthy (President, REF):

- 501c3 organization
- Objective is to raise public funds and offer grants to individual educator or specific dept or school

• Funds not used to cover curriculum; independent of BOE and does not interfere with curriculum but enhance curriculum

- Examples of past funded projects: Funded classroom grants, leadership grants (ex Learning Commons at RHS), Chromebook 1:1 initiative, classroom which expanded to all students; renovated science classrooms at BF and GW to support STEAM program; 4 year STEAM initiative grant ex MakerSpace at RHS now expended to lower level schools
- Community grants: Super Science Saturday sponsor
- Applicants should fill out grant request form and then must be approved by various members
