AMERICAN INVITATIONAL MATHEMATICS EXAMINATION

Jaywu Jun, Hyewon Park, and Margaret Zhou qualified for the 2023 American Invitational Mathematics Examination (the AIME). Students qualify for this exam by demonstrating outstanding achievement in the American Mathematics Competition (AMC). Jaywu and Hyewon were each in the top 5% of test takers nationally on the AMC 12 exam. Margaret was in the top 2.5% of all test takers nationally on the AMC 10.

Using new equipment that was purchased with a grant from the Dave & Cheryl Duffield Foundation, the RHS Recording Studio Club and the RHS TV Club launched a new series, In the Studio.

SUSTAINABLE JERSEY FOR SCHOOLS

Seven schools were recognized for achieving bronze-level certification from Sustainable Jersey for Schools in 2022: Ridgewood High School, Benjamin Franklin Middle School, George Washington Middle School, Orchard Elementary School, Ridge Elementary School, Somerville Elementary School, and Travell Elementary School. Two schools were certified for the first time (Orchard Elementary School and George Washington Middle School). These schools are part of a cohort of 158 schools that were certified this year. This certification demonstrates a commitment to sustainability, encompassing a large range of areas and actions.

NATIONAL MERIT SCHOLARSHIP PROGRAM

Four Ridgewood High School students, Chloe Cho, Ethan Holden, Kate Minn, and Lucas Wong, were advanced to the Finalist round, the highest-scoring entrants in each state representing less than one percent of U.S. high school seniors. In addition to the four Finalists, 29 students from Ridgewood High School were designated as Commended Students.




